Treasury

Nerissa asked for feedback on what amount should be donated to Dr Tarpy and apiary research. It was decided that we would donate \$2,500, same as last year plus the \$575 proceeds from the silent auction. Nerissa will send two separate checks. We have two checking accounts with \$6800 in one and \$19,000 In the other.

The question was asked whether we needed to file taxes. Mark emailed John Rintoul and he responded immediately:

"OCBA is registered as an NC non-profit. OCBA has not applied for federal tax exempt status as a non-profit (also known as IRS 501(c)(3) status). The IRS 990 short or long form is applicable only to 501(c)(3) organizations.

To my knowledge OCBA does not have enough income to meet threshold income reporting requirements at either the state or federal level so no tax return is required as things now stand. Thresholds may have changed, but it would be unlikely.

If OCBA decides to pursue tax exempt status under federal IRS guidelines, **then** IRS 990 form would need to be filed each year irrespective of OCBA's annual income.

The advantages of federal tax exempt status are: 1) OCBA would be able to offer tax exempt advantages to donors; and 2) many small grants are specifically restricted to 501(c)(3) tax exempt organizations.

The disadvantages of federal tax exempt status are: 1) someone will have to pursue 501(c)(3) exemption status on behalf of OCBA; and 2) someone will have to file IRS Form 990 each year thereafter."

Celeste, Nerissa, and Larry will meet at BBT to change over signatures on the accounts. Cynthia will send a copy of the November meeting minutes with new officer election results as required by the bank.

Dawn turned the state fair winnings of \$266. over to Nerissa.

Ryan brought up the question again of how to handle the lifetime membership dues. Randall suggested a separate account.

The church contract for rental of the space for the bee school and for the monthly meetings has been shared between Ryan, Celeste, and Carrie. Larry will pay in early January.

Outreach

Dawn as the new outreach director has received materials from Chris except for one table and a set of keys to the gate and to the Milk Room (storage) at Blackwood.

Dawn will send a check for \$266 to Larry for the state fair winnings.

She has received a request from Pine Woods Montessori School for a visit to 2 groups of 40 each in December which will be postponed until January. Randall suggested that a mention of outreach activities be mentioned and applauded at the monthly meetings to let others know how much fun they are and to encourage more participation.
